RIGHT OF WAY Robert G. Wilson and Irene Wilson, his wife, Route #1, Mikado, Michigan first parties...

The West 1/2 of the Southwest 1/4 of Section 6 and the Northwest 1/4 of the Northwest 1/4 of Section 7, all in Township 25 North, Range 8 East.

The route to be taken by said lines of wires, poles, wires, cables and conduits across, over and under said land being more specifically described as follows:

In a N'ly and S'ly and NE'ly and SW'ly dir. along or adjoining as near as practicable a line, which sd. line is desc. as beg. on the E & W 1/4 line of Sec. 7, T25N, R8E, at a point not more than 200 ft. East of the West line of sd. Sec., run th. N'ly along and not more than 200 ft. East of the West line of sd. Sec. 7 and the West line of Sec. 6 of sd. Twp. to a point not more than 350 ft. nor less than 150 ft. North of the South line of sd. Sec. 6, th. NE'ly to a point not more than 450 ft. nor less than 250 ft. East of the West line of Sec. 28, T26N, R8E, at a point not more than 400 ft. nor less than 200 ft. North of the South line of sd. Sec. 28.

With full right and authority to the second party, its successors, licensees, lessees or assigns, and its and their agents and employees, to enter at all times upon said premises for the purpose of constructing, repairing, removing, replacing, patrolling, improving, enlarging and maintaining such cables, conduits, poles and other supports, with all necessary braces, guys, anchors, manholes and transformers, and stringing thereon and supporting and suspending therefrom lines of wire, cables or other conductors for the transmission of electrical energy and/or communication, and to trim, remove, destroy or otherwise control any trees and brush which may, in the opinion of said second party, interfere or threaten to interfere with or be hazardous to the construction, operation and maintenance of said lines. It is expressly understood that no buildings or other structures will be placed under such wires and/or over such cables without the written consent of said second party. It is expressly understood that non-use or a limited use of this easement by second party shall not prevent second party from later making use of the easement to the full extent herein authorized.
