THIS INVENTORY, Made this 1st day of April,  
A.D. 1954, between CONSUMING POWER COMPANY, a corporation duly authorized to  
do business in Michigan, with its principal office in Jackson, Michigan, as  
first party, and ALPENA POWER COMPANY, a corporation duly authorized to do  
business in Michigan, with its principal office in Alpene, Michigan, as second  
party,

## WITNESSETH:

The said first party for and in consideration of the sum of One Dollar (\$1.00) and other valuable considerations to it in hand paid by the said second party, the receipt whereof is hereby acknowledged and acknowledged, does by these presents grant, bargain, sell, release and MORTGAGE unto the said second party, its successors and assigns, forever, the exclusive and right to erect, lay and maintain electric transmission lines consisting of poles, wires, cables, conduits and other fixtures and appurtenances for the purpose of transmitting and distributing electricity on, over, under and across the following described parcels of land, including all public highways upon or adjacent to said parcels of land, hereinafter more particularly described and or routes as hereinafter designated, situated in the Townships of Willow and Green, Alpena County, State of Michigan, to-wit:

## 1.

The Southeast one-quarter (SW<sub>1</sub>) of the Southeast one-quarter (SW<sub>1</sub>), the Southwest one-quarter (SW<sub>2</sub>) of the Southwest one-quarter (SW<sub>1</sub>) of Section thirty-one (31), Township thirty-one (31) North, Range seven (7) East. The East fractional one-half (X 1/2) of the Northeast one-quarter (NW<sub>1</sub>), the West fractional one-half (W 1/2) of the Northwest one-quarter (NW<sub>1</sub>) of Section five (5), Township thirty (30) North, Range seven (7) East. The East one-half (E) of the Northeast one-quarter (NW<sub>1</sub>), the West one-half (W) of the Northeast one-quarter (NW<sub>1</sub>) and the Northwest one-quarter (NW<sub>2</sub>) of the Southeast one-quarter (SW<sub>2</sub>) of Section six (6), Township thirty (30) North, Range seven (7) East.

The route to be taken by said lines of poles, wires, cables and conduits across said land being described as follows:

Said line of poles and wires shall be located on a strip of land fifty (50) feet wide, the Southerly line of said strip being the center line of the former Bayne City-Dayland and Alpene Railroad right of way, which center line is described as beginning at a point on the East line of Section thirty-one (31), Township thirty-one (31) North, Range seven (7) East, at a point ten hundred thirty-three (1033) feet North of the Southeast corner of said Section, running thence Southwesterly in a straight line to a point on the West line of Section five (5), Township thirty (30) North, Range seven (7) East, eight hundred fifty-five (855) feet South of the Northwest corner of said Section five (5) and continuing thence Southwesterly in a straight line on the same course to a point on the West line of the Northwest one-quarter (NW<sub>1</sub>) of the Southeast one-quarter (SW<sub>2</sub>) of Section six (6), Township thirty (30) North, Range seven (7) East, at a point one hundred twenty (120) feet South of the Northwest corner of the Northwest one-quarter (NW<sub>1</sub>) of the Southeast one-quarter (SW<sub>2</sub>) of said Section six (6).

## 2.

The North one-half (N) of the Southwest one-quarter (SW<sub>1</sub>) of the Southeast one-quarter (SW<sub>1</sub>) of Section six (6), Township thirty (30) North, Range seven (7) East; the North one-half (N) of the Northwest one-quarter (NW<sub>1</sub>) of Section twelve (12), Township thirty (30) North, Range six (6) East.

The route to be taken by said lines of poles, wires, cables, and conduits across said land being described as follows:

Said line of poles and wires shall be located on a strip of land fifty (50) feet wide, the Southerly line of said strip being described as beginning at a point on the North and South quarter line of said Section six (6), Township thirty (30) North, Range seven (7) East, at its intersection with the center line of grade of the former Boyne City-Gaylord and Alpena Railroad right of way, running thence Southwesterly along the center line of said grade to a point not more than nine hundred (900) feet nor less than seven hundred (700) feet East of the West line of said Section six (6), measured at right angles thereto, running thence Southwesterly to a point not more than one hundred (100) feet East of the West line of said Section six (6) at a point not more than eleven hundred (1100) feet and not less than nine hundred (900) feet North of the South line of said Section six (6), running thence Southwesterly in a straight line to the center line of the grade of the Boyne City-Gaylord and Alpena Railroad right of way at a point not more than one hundred (100) feet East of the West line of Section twelve (12), Township thirty (30) North, Range six (6) East, running thence Southwesterly along the center line of grade of said Railroad right of way to the West line of said Section twelve (12).

The North one-half ( $\frac{1}{2}$ ) of the Northeast one-quarter ( $\text{NEQ}$ ), the South one-half ( $\frac{1}{2}$ ) of the Northeast one-quarter ( $\text{NEQ}$ ), the Northwest one-quarter ( $\text{NWQ}$ ) of Section eleven (11); the South one-half ( $\frac{1}{2}$ ) of the Northeast one-quarter ( $\text{NEQ}$ ), the North one-half ( $\frac{1}{2}$ ) of the Northwest one-quarter ( $\text{NWQ}$ ) and the North one-half ( $\frac{1}{2}$ ) of the Southwest one-quarter ( $\text{SWQ}$ ) of Section ten (10), the North one-half ( $\frac{1}{2}$ ) of the Southeast one-quarter ( $\text{SEQ}$ ) of Section nine (9), except the West sixteen hundred forty-six (1646) feet thereof, being all in Township thirty (30) North, Range six (6) East.

The route to be taken by said lines of poles, wires, cables and conductors over said land being described as follows:

Said line of poles and wires shall be located on a strip of land fifty (50) feet wide, the Southerly line of said strip being the center line of the former Boyne City-Gaylord and Alpena Railroad right of way, which center line is described as beginning at a point on the East line of Section eleven (11), Township thirty (30) North, Range six (6) East, at a point eight hundred fifty-six (856) feet South of the Northwest corner of said Section, running thence Southwesterly in a course sixty-four degrees forty-eight minutes West ( $54^{\circ} 48' W$ ) three thousand two hundred twenty-nine (3229) feet to a point of curve, thence on a one degree thirty minutes ( $1^{\circ} 30'$ ) curve to the right fifteen hundred eighteen (1518) feet to a point of tangency, thence South eighty-one degrees thirty-three minutes West ( $81^{\circ} 33' W$ ) a distance of three thousand two hundred eighty (3280) feet to a point of curve, thence on a thirty minutes ( $30'$ ) curve to the left a distance of seven hundred thirty-three (733) feet to a point of tangency, thence South eighty-three degrees fifty-three minutes West ( $83^{\circ} 53' W$ ) to a point sixteen hundred forty-six (1646) feet East of and measured at right angles from the North and South quarter line of Section nine (9), Township thirty (30) North, Range six (6) East, to a point of terminus, in accordance with the original survey of the former Boyne City-Gaylord and Alpena Railroad.

With full right and authority to the second party, its successors, licensees, lessees or assigns, and its and their agents and employees, to enter at all times upon said premises for the purpose of constructing, repairing, removing, replacing, improving, enlarging and maintaining such cables, conduits and poles and other supports, with all necessary braces, guys, anchors, manholes and transformers, and strung thereon and supporting and suspending therefrom lines of wire, cables or other conductors for

the transmission of electrical energy and/or communication, and to trim, remove, destroy or otherwise control any trees and brush which may, in the opinion of said second party, interfere or threaten to interfere with or be injurious to the construction, operation and maintenance of said lines. It is mutually understood that no buildings or other structures will be placed within such lines and/or over such cables without the written consent of said second party. It is mutually understood that non-use or a limitation of this agreement by second party shall not prevent second party from later filing two of the consent to the full scope herein authorized.

 successors and assigns, forever, the easement and right to erect, lay and maintain lines consisting of ~~poles~~ poles, wires, cables,  
 conduits and other fixtures and appurtenances for the purpose of transmitting and distributing electricity and/or conducting a com-  
 munication business on, over, under and across the following described parcel . . . of land, including all public highways upon or  
 adjacent to said parcel . . . of land, which parcel . . . is situated in the Township . . . of . . . Wilson . . . County  
 of . . . Alpena . . . and State of Michigan, to-wit:  
 A strip of land one hundred (100) feet wide running in a Northeasterly and Southwesterly  
 direction across the North one-half ( $\frac{1}{2}$ ) of the Northwest one-quarter ( $\frac{1}{4}$ ) of Section twelve

With full right and authority to the second party, its successors, licensees, lessees or assigns, and its and their agents and employees, to enter at all times upon said premises for the purpose of constructing, repairing, removing, replacing, improving, enlarging and maintaining such cables, conduits and ~~poles~~, poles and other supports, with all necessary braces, guys, anchors, manholes and transformers, and stringing thereon and supporting and suspending therefrom lines of wire, cables or other conductors for the transmission of electrical energy and/or communication, and to trim, remove, destroy or otherwise control any trees and brush which may, in the opinion of said second party, interfere or threaten to interfere with or be hazardous to the construction, operation and maintenance of said lines. It is expressly understood that no buildings or other structures will be placed under such wires and/or over such cables without the written consent of said second party. It is expressly understood that non-use or a limited use of this easement by second party shall not prevent second party from later making use of the easement to the full extent herein authorized. Second party to pay at the rate of Eighty Dollars (\$80.00) per mile of length of the line of poles and wires across said above described premises, the same to be paid before any work is done on the land, and also to pay for any damage to crops in erecting and maintaining said line of poles and wires.
