WITNESSETH:

That the said party of the first part, for and in consideration of the sum of One Dollar (\$1.00) and other valuable considerations to it in hand paid by the said party of the second part, the receipt whereof is hereby confessed and acknowledged, does by these presents bargain, sell, remise, release and Forever QUIT-CLAIM unto the said party of the second part, its successors and assigns, Forever, all those certain pieces or parcels of land situate in the Townships of Wilson and Green, County of Alpena and State of Michigan, known and described as follows, to-wit:

All that part of the Southerly one-half (S'ly 1/2) of the former Boyne City-Gaylord and Alpena Railroad right of way, being the Southerly fifty (50) feet of a one hundred (100) foot strip of land formerly occupied by said Railroad, running from the East line of Section thirty-one (31), Township thirty-one (31) North, Range seven (7) East, Southwesterly across said Section thirty-one (31) and Sections five (5) and six (6) of Township thirty (30) North, Range seven (7) East and Sections ten (10), eleven (11) and the East one-half (E 1/2) of Section nine (9), except the West sixteen hundred forty-six (1646) feet thereof, all in Township thirty (30) North, Range six (6) East.
