PLAT OR AREA

William Grace and Gretchen Grace, his wife, and in her own right  
first part, for consideration of One Dollar (\$1.00) to them  
paid by the CONSUMERS POWER COMPANY, a Maine corporation authorized to do business in Michigan, at 212 W. Michigan Ave., Jackson, Michigan, second party, receipt of which is hereby acknowledged, convey and warrant to the second party, its successors and assigns, forever, the easement and right to erect, lay and maintain lines consisting of poles, wires, cables, conduits and other fixtures and appurtenances for the purpose of transmitting and distributing electricity and/or conducting a communication business on, over, under and across the following described parcel of land, including all public highways upon or adjacent to said parcel of land, which parcels are situate in the Township of Alpena County of Alpena and State of Michigan, to-wit:

Bounded by a line commencing at a point on Sec line between section 4 and 5 Town 31 North of R 8 E, 6 rods North of Southeast corner of Southeast Quarter of Northeast Quarter of sd sec 5; thence Northeasterly on Sec line 6 rods; Thence Westerly at right angles to sd sec line 26 2/3 rods; thence Southeasterly and parallel to said sec line 6 rods; thence Easterly 26 2/3 rods to point of beginning.  
Also a strip of land 6 rods in width off the South side of Southeast Quarter of North east Quarter of Section 5, all in Town 31 North of Range 8 East.

The route to be taken by said lines of poles, wires, cables and conduits across, over and under said land being more specifically described as follows: Sec. party may locate sd rte on, over and across sd above desc. land, alg. or adj. as near as prac. a line, which sd line is desc, as beg at a point not more than 1000 ft nor less than 700 ft West of the north and south 1/4 line of Sec 4, T33 N. R8E, at a point not more than 150 ft nor less than 100 ft north of the East and West 1/4 line of sd Sec 4, running thence Westerly to a point not more than 450 ft nor less than 300 ft West of the East Sec line of Sec 5, at a point not more than 150 ft nor less than 100 ft North of the East and West 1/4 line of sd sec 5 running thence Southerly to a point not more than 1050 ft nor less than 850 ft North of the South sec line of sd sec 5 to point not more than 400 ft nor less than 250 ft West of the East Sec line of sd Sec 5.  
With full right and authority to the second party, its successors, licensees, lessees or assigns, and its and their agents and employees, to enter at all times upon said premises for the purpose of constructing, repairing, removing, replacing, improving, enlarging and maintaining such cables, conduits and poles and other supports, with all necessary braces, guys, anchors, manholes and transformers, and stringing thereon and supporting and suspending therefrom lines of wire, cables or other conductors for the transmission of electrical energy and/or communication, and to trim or remove any trees which at any time may interfere or threaten to interfere with the maintenance of such lines. It is expressly understood that no buildings or other structures will be placed under such wires and/or over such cables without the written consent of said second party. It is expressly understood that non-use or a limited use of this easement by second party shall not prevent second party from later making use of the easement to the full extent herein authorized. Second party to pay at the rate of Eighty Dollars (\$80.00) per mile of length of the line of poles and wires across said above described premises, the same to be paid before any work is done on the land, and also to pay for any damage to crops in erecting and maintaining said line of poles and wires.
