 successors and assigns. Forever, the easement and right to erect, lay and maintain lines consisting of ~~wood~~ poles, wires, cables,  
 conduits and other fixtures and appurtenances for the purpose of transmitting and distributing electricity and/or conducting a com-  
 munication business on, over, under and across the following described parcel of land, including all public highways upon or  
 adjacent to said parcel of land, which parcel is situated in the Township of Alpena County of Alpena and State of Michigan, to-wit:

The Southwest 1/4 of the Southwest 1/4 of Section 19, Township 31 North, Range 8 East, except the South 250 feet thereof.

The route to be taken by said lines of ~~wood~~ poles, wires, cables and conduits across, over and under said land being more specif-  
 ically described as follows:

Second party may locate sd. rte. on, over and across sd. above described land, along or adj. as near  
 as practicable a line, which sd. line is described as beginning at a point not more than 165 ft.  
 nor less than 100 ft. E of the W line of Sec. 30, T31N, R8E, at a point not more than 400 ft. nor  
 less than 300 ft. S of the W line of sd. Sec., run th. N'ly along and not more than 165 ft. nor  
 less than 100 ft. distant E of the W line of sd. Sec. 30 and 19, to a point not more than 360 ft.  
 nor less than 330 ft. N of the S line of Sec. 19 of sd. Twp., run th. NE'ly to intersect CPO's  
 present exist. elec. trans. line at a point not more than 200 ft. N of the S, E and W 1/8 line  
 of sd. Sec. 19, at a point not more than 450 ft. nor less than 350 ft. E of the W line of sd.  
 Sec. 19.

With full right and authority to the second party, its successors, licensees, lessees or assigns, and its and their agents and employees,  
 to enter at all times upon said premises for the purpose of constructing, repairing, removing, replacing, patrolling, improving,  
 enlarging and maintaining such cables, conduits and ~~wood~~ poles and other supports, with all necessary braces, guys, anchors  
 manholes and transformers, and stringing thereon and supporting and suspending therefrom lines of wire, cables or other conductors  
 for the transmission of electrical energy and/or communication, and to trim, remove, destroy or otherwise control any trees and  
 brush which may, in the opinion of said second party, interfere or threaten to interfere with or be hazardous to the construction,  
 operation and maintenance of said lines. It is expressly understood that no buildings or other structures will be placed under such  
 wires and/or over such cables without the written consent of said second party. It is expressly understood that non-use or a limited  
 use of this easement by second party shall not prevent second party from later making use of the easement to the full extent herein  
 authorized.
