WARRANTY DEED.—SHORT FORM. No. 1. F. A. Onderdonk, Grand Rapids, Mich.

This Indenture, Made this 23rd day of December in the year of our Lord one thousand nine hundred and Sixty

BETWEEN Mrs John (sometimes written Eliza) Lafave, of the Township of Standish, Arenac County Michigan of the first part, and Eastern Michigan Power Co. a corporation organized and done up in accordance with the laws of the State of Michigan with its principal office in the City of Au Sable, Mich. of the second part, Witnesseth, That the said part 1 of the first part, for and in consideration of the sum of One Dollar and other valuable consideration Dollars, to her in hand paid by the said part 2 of the second part, the receipt whereof is hereby confessed and acknowledged, do hereby by these presents grant, bargain, sell, remise, release, alien and confirm unto the said part 2 of the second part, and its successors and assigns, FOREVER, all that certain piece or parcel of land situate and being in the Township of Standish County of Arenac and State of Michigan, and described as follows, to-wit:

A strip of land two (2) rods in width along, adjoining and parallel with the eastern line of the Detroit and Mackinac Railway right of way across the south-west quarter (1/4) of the north-east quarter (1/4) of Section Seventeen (17) Township Eighteen (18) north of Tier (5) east.

First party reserved the right of ingress and egress across said land.
