BETWEEN Nancy Harris formerly Nancy Caly

of the first part, and Eastern Michigan Power Company, a corporation formed and existing under the laws of the State of Michigan with its principal office in the City of Au Sable, Iosco County, Michigan, of the second part.

Witnesseth, That the said part Y of the first part, for and in consideration of the sum of One Dollar and other valuable considerations to her in hand paid by the said part Y of the second part, the receipt whereof is hereby confessed and acknowledged, do as by these presents, grant, bargain, sell, remise, release and forever QUIT-CLAIM unto the said part Y of the second part, and to its successors and assigns, Forever, All that certain piece or parcel of land, situated in the Township of Standish in Arenac County, and State of Michigan, known and described as follows:

A strip of land four (4) rods in width along and adjoining and parallel with the Easterly line of the Detroit & Mackinac Railway Right of Way across all that part of the West six (6) acres of the East eighteen (18) acres of the Northwest one quarter (1/4) of the Southeast one quarter (1/4) of Section thirty (30) of Township eighteen (18) North of Range five (5) East, lying East of the Detroit & Mackinac Railway Right of Way.
