WARRANTY DEED-Long.

This Indenture, Made this 19th day of August 1962 in the year of our Lord one thousand nine hundred and eleven
BETWEEN Ormar E. Bradley, and Ada A. Bradley, his wife, and Mrs. W. Bradley, and Bruce S. Bradley, his wife, all of Gay City, Michigan of the first part, and the Eastern Michigan Power Company, a corporation organized under the laws of the state of Michigan of the second part.

Witnesseth, That the said party of the first part, for and in consideration of the sum of One Dollar to them in hand paid by the said party of the second part, the receipt whereof is hereby confessed and acknowledged, have granted, bargained, sold, remised, released, aliened and confirmed, and by these presents do grant, bargain, sell, remise, release, alien and confirm unto the said party of the second part, and to its heirs and assigns, FOREVER, all three certain pieces or parcels of land situate and being in the Township of Standish County of Arenac and State of Michigan.

and described as follows, to-wit: A strip of land four rods wide on the east side of, parallel to and adjacent to the right of way, of the Detroit & Mackinac Railroad Company, commencing at the north line of the south west quarter of the south east quarter of Section 30 Town 18, N. R. 5 East and extending thence southerly and westerly along side of said right of way about 52 rods to the east line of land now owned by P. B. Cameron. Also a strip of land four rods wide on the east side of, parallel to and adjacent to the right of way, of the Detroit & Mackinac Railroad Company, commencing at the north line of the north west quarter of north east quarter of Section 31 in Town 18, N. R. 5 East and extending thence southerly and westerly along side of said right of way about 2 1/2 rods to the east line of the north east quarter of north west quarter of said Section Thirty one (31) Town 18, N. R. 5 East; containing in all about 2 1/2 acres of land more or less.

It is understood that grantors and their heirs and assigns have the right to crop said land until second party may want to use the surface and that second party shall when requested so to do by grantors, enclose said land with a legal fence.
