RIGHT OF WAY

John B. Sauve, a widower, and Emery J. Sauve and Cora E. Sauve, his wife,

of the first part, in consideration of One (\$1.00) Dollars to them paid by the EASTERN MICHIGAN POWER COMPANY a corporation organized under the laws of Michigan...

The route to be taken by said line of towers and wires across said land being more specifically described as follows: Towers to be set East of and along and adjoining the Easterly line of the Detroit & Mackinac Railway Right of Way on, over and across said land.

With full right and authority to the party of the second part, its successors or assigns, and its and their agents, servants and employees, to enter at all times upon said premises for the purpose of constructing, repairing, removing, replacing and maintaining such towers, poles, cross arms and wires...

Second party to pay first party the sum of Twenty five (\$25.00) Dollars for each tower set on said land, the same to be paid before the towers are set, and also for any damage to crops in erecting and maintaining the line of towers and wires.
