> That part of the South one-half  $(\frac{1}{2})$  of the South one-half  $(\frac{1}{2})$ of the Southeast one-quarter  $(\frac{1}{6})$  of Section nineteen (19), Township eighteen (18) North, Range five (5) East, lying Easterly of the Detroit and Mackinac Railway right of way, except a strip of land four (4) rods wide off the Westerly side thereof.

The route to be taken by said lines of poles, wires, cables and conduits across, over and under said land being more specifically described as follows:

Second party may locate said route East of and along and not more than 76 feet from the Easterly line of the Detroit and Mackinac Railway right of way.

It is expressly understood that no buildings or other structures will be placed under such wires and/or over such cables without the written consent of said second party. It is expressly understood that non-use or a limited use of this easement by second party shall not prevent second party from later making use of the easement to the full extent herein authorized.
