Witnesseth, that the said part 1st of the first part, for and in consideration of the sum of Three hundred (\$300.00) dollars, to them in hand paid by the said part 2<sup>d</sup> of the second part, the receipt whereof is hereby confessed and acknowledged, do they by these presents grant, bargain, sell, remise, release, alien and confirm unto the said part 2<sup>d</sup> of the second part, and its successors heirs and assigns, forever, all that certain piece or parcel of land situate and being in the Township of Arenac County of Arenac and state of Michigan, and described as follows, to-wit: A strip of land four (4) rods in width, next to and adjoining the easterly line of the Detroit & Mackinac Ry right of way across the south east one quarter (1/4) of the north east quarter and the north east one quarter of the south east one quarter (1/4) all in section two (2) township nineteen (19) north Range Five (5) east Township a piece of land containing twenty three and eight acres that was purchased from Parky H. Hunt by J. H. Orr and a piece of land sold by first party to North Michigan Engineering Association of Seventh Day Adventists. First party reserves the right to cross and run across above land.
