This Indenture,

Made this 19th day of August in the year of our Lord one thousand nine hundred ten BETWEEN Lawrence O. Osborne and Louise Osborne his wife of the first part, and Eastern Michigan Power Company a corporation with its principal office in Lansing, Michigan of the second part:

Witnesseth, That the said Lawrence O. Osborne and Louise Osborne part of the first part, conveys and warrants to the said Eastern Michigan Power Company part of the second part, all that certain piece or parcel of land situate and being in the Township of Arenac County of Michigan, State of Michigan, and described as follows, to wit:

A strip of land four (4) rods in width along and adjoining the easterly side of the right of way of the Detroit Mackinac Roadway across the north half (1/2) of the North West Quarter (1/4) section twenty-seven (27) Town 19 North (19) Range 5 East

for the sum of One Dollar and other valuable considerations lawful money of the United States of America, to them in hand paid by the said part of the second part, the receipt whereof is hereby confessed and acknowledged.

Second party grants to first parties the right to use said strip as long as it does not interfere with second party or until second party may fence said strip
