of the first part, in consideration of one one one Dollars to her paid by the EASTERN MICHIGAN POWER COMPANY, a corporation organized under the laws of Michigan, of the second part, receipt of which is hereby acknowledged, Convey and Warrant to the party of the second part, its successors and assigns, Forever, the easement and right to maintain electric lines, consisting of towers, poles, wires and distributing appliances for the purpose of transmitting, distributing and commercially using electricity on, over and across the following described parcel of land in the Township of Turner, County of Arenac and State of Michigan, to wit: A piece of land commencing at a point thirty nine and one half (39 1/2) rods south from the north line of the north west one quarter (NW 1/4) of the north west one quarter (NW 1/4) of Section 17, Thence running south fourteen (14) rods and road side of highway, thence east sixteen (16) rods, thence twelve rods north, thence north westerly in center of ditch to place of beginning, in T. 20 N. R. 6 E.

The route to be taken by said line of poles or towers and wires across said land being more specifically described as follows: side of highway, thence east sixteen (16) rods, thence twelve rods north, thence north westerly in center of ditch to place of beginning, in T. 20 N. R. 6 E.

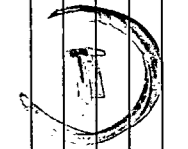
With full right and authority to the party of the second part, its successors or assigns, and its and their agents, servants and employees, to enter at all times upon said premises for the purpose of constructing, repairing, removing, replacing and maintaining such towers, poles or other supports, with all necessary braces, guys, anchors and transformers, and stringing thereon and supporting and suspending therefrom lines of wire or other conductors, for the transmission of electrical energy, and to trim or remove any trees which at any time may interfere or threaten to interfere with the maintenance of such lines. Second party agrees to pay first party the sum of five dollars each for all towers set on above described land, same to be paid before towers are set
