Saginaw Milling Co. of Saginaw of the first part in consideration of One Dollar to them paid by the Eastern Michigan Power Company, a corporation organized under the laws of Michigan of the second part, receipt of which is hereby acknowledged, Convey and Warrant to the party of the second part, its successors and assigns, Forever, the easement and right to maintain electric lines, consisting of towers, poles, wires, and distributing appliances for the purpose of transmitting, distributing and commercially using electricity on, over and across the following described parcel of land in the Village of Twining, County of Arenac and State of Michigan, to wit:

All of that part of Out Lot in Block One (1) lying north of the spur running east from main line of D. & M.Ry.

The route to be taken by said line of poles or towers and wires across said land being more specifically described as follows:

With full right and authority to the party of the second part its successors or assigns, and its and their agents, servants and employees, to enter at all times upon said premises for the purpose of constructing, repairing, removing, replacing and maintaining such towers, poles or other supports, with all necessary braces, guys, anchors, and transformers, and stringing thereon and supporting and suspending therefrom lines of wire or other conductors, for the transmission of electrical energy, and to trim or remove any trees which at any time may interfere or threaten to interfere with the maintenance of such lines, This is for overhanging only. No towers to be set on above land.

The Easement as shown on the caption of this tract, (according to the old record sheet) states "The Easement not executed by proper officers of the Company, and no seal of the Milling Company is attached."
