All that part of Outlot One (1), Block One (1) of the Village of Twining, according to the recorded plat thereof, lying South of the Detroit, Mackinac Railroad Spur, running East from the main line of said Railroad across said Outlot, EXCEPTING a right of way granted to the Eastern Michigan Power Company.
