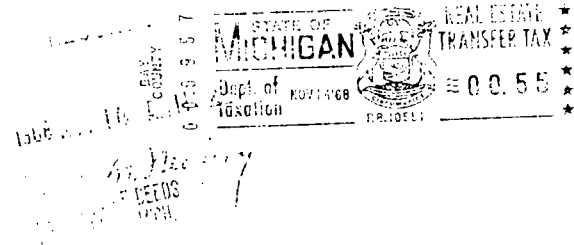

 land, said land being in the Township of Merritt County of Bay

The East 24 feet of the Southwest  $\frac{1}{4}$  of the Southeast  $\frac{1}{4}$  of Section 29, Township 13 North, Range 6 East, except Highway M-115.

 Grantee from later making use of said easement and rights to the full extent herein authorized. It is further agreed that the  
 consideration received by Grantor for this easement shall be in full payment for the easement and rights hereby granted and  
 for all trees and brush now or hereafter standing or growing on said land.
