Township of Fraser County of Bay and State of Michigan, to-wit: The north one (1/2) half of the southwest one (1/4) quarter of the southwest one (1/4) quarter of Section Thirty-five (35); and the south one (1/2) half of the northwest one (1/4) quarter of the southwest one (1/4) quarter of Section Thirty-five (35), Town Sixteen, north Range Four (4) east...

The route to be taken by said line of poles or towers and wires across said land being more specifically described as follows:

Towers to be set on the east side of and next to the east line of highway on west side of above described land.

Second parties to pay parties of the first part five (\$5.00) dollars for each tower set on above described land.

With full right and authority to the party of the second part, its successors or assigns, and its and their agents, servants and employees, to enter at all times upon said premises for the purpose of constructing, repairing, removing, replacing and maintaining such towers, poles or other supports, with all necessary braces, guys, anchors and transformers, and stringing thereon and supporting and suspending therefrom lines of wire or other conductors, for the transmission of electrical energy, and to trim or remove any trees which at any time may interfere or threaten to interfere with the maintenance of such lines.

This grant is made to correct a like easement recorded in the Register's office, Bay County, Mich. in Liber 123 of Deeds, page 350, wherein the grantor is not described as unmarried.
