IN CONSIDERATION of the sum of One Dollar (\$1.00) and other valuable considerations, receipt of which is hereby acknowledged, We hereby grant to THE DETROIT EDISON COMPANY, its successors and assigns, the right to construct, operate and maintain its lines for the transmission and distribution of electricity and Company communication facilities, including the necessary poles, fixtures, guys and guy stubs, wires and equipment, and including also the right to trim or cut down any trees along said lines, which could fall into the lines or interfere in any way with their operation, upon, over and across our property located in

SECTION 12, HADLEY TOWNSHIP

STREET AND VILLAGE, OR SECTION AND TOWNSHIP

County of LAPEER, State of Michigan, and described as follows:

The East 50 acres of the North Half of the Northwest Quarter, Section 12, T6N, R9E.

The route of the lines shall be as follows: Over and across the above-described property approximately 250 feet South of the new Palmer Road, or Pratt Road so-called. Permission is hereby granted to cut down and keep clear of all trees, an Easterly and Westerly strip 30 feet wide, approximately 250 feet South of the new Palmer Road, or Pratt Road so-called.

Cut trees into buzz wood. Clean up brush.

The Company, its successors and assigns, shall reimburse us for all damage to growing crops, buildings or fences, caused by its men, teams, trucks and other vehicles and equipment in entering said property from time to time for the purposes set forth herein.
