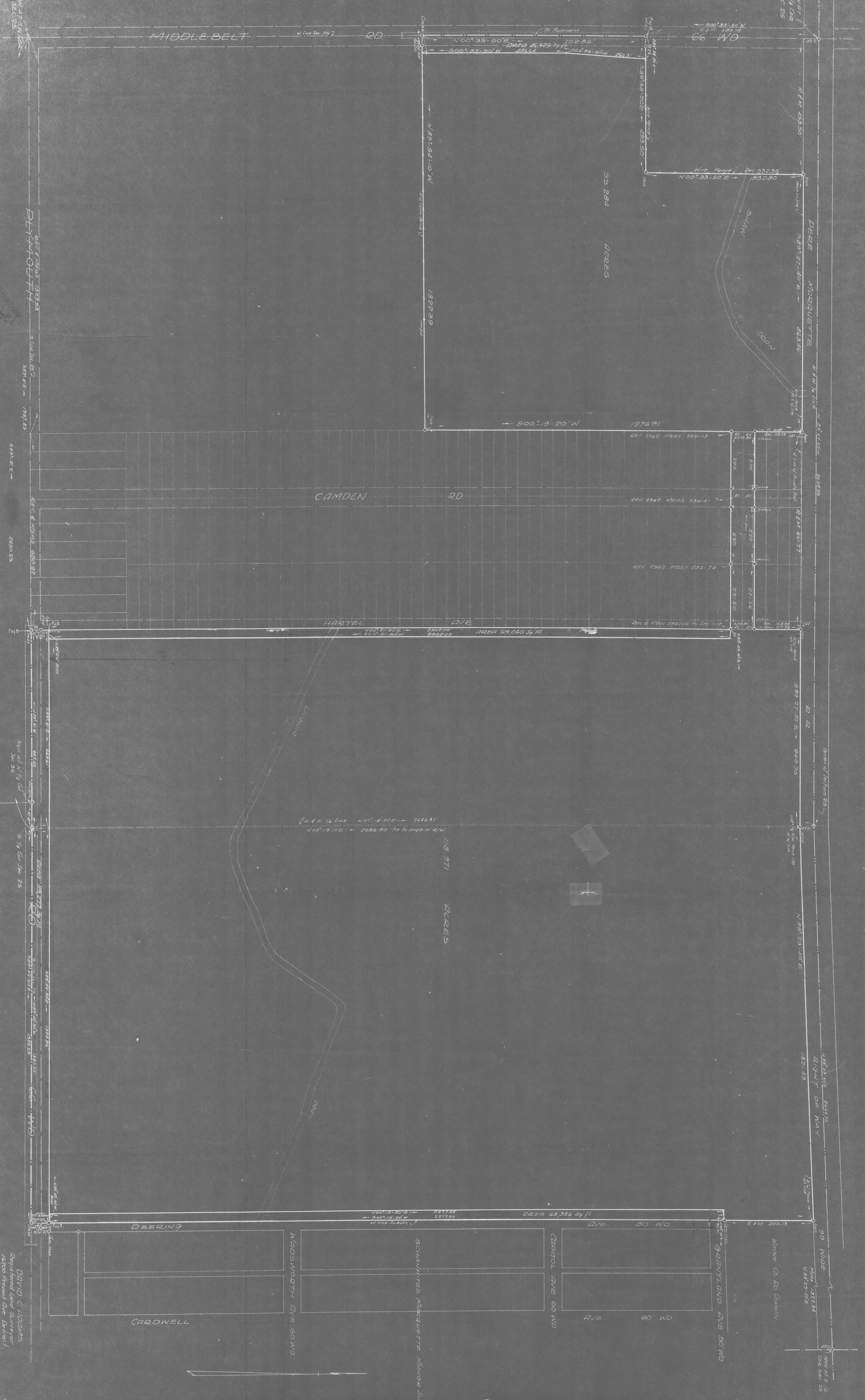
SURVEY OF PART OF THE SOUTH HALF OF SECTION 25,
