IN CONSIDERATION of the sum of \$500.00 and other valuable considerations, receipt of which is hereby acknowledged, we hereby grant to THE DETROIT EDISON COMPANY, its successors and assigns, the right to construct, operate and maintain its lines for the transmission and distribution of electricity and Company communication facilities, including the necessary poles, fixtures, guys and guy stubs, wires and equipment, and including also the right to trim or cut down any trees along said lines, which could fall into the lines or interfere in any way with their operation upon, over and across our property located in Livonia

County of Wayne State of Michigan, and described as follows:
The West half of the West half of the Southeast quarter of Section 26, except the North 49.50 feet thereof. All in T1S, R9E.

The route of the lines shall be as follows: In an easterly and westerly direction across said land along approximately 5 feet South of and parallel to the Pere Marquette Railroad Right-of-Way. This agreement includes also the right to clear and keep clear of trees a strip 3 rods wide along said route, and any other trees outside said strip that could fall into the lines or interfere with their operation.

The Company shall reimburse us for all damage to growing crops, buildings or fences, caused by its men, teams, trucks and other vehicles and equipment in entering said property for the purpose set forth herein.

In addition to the above consideration, the Company shall pay us the sum of Five and no/100 (\$5.00) Dollars each pole on said land, the same to be paid before any poles are erected.
