IN CONSIDERATION of the sum of One Dollar (\$1.00) and other valuable considerations, receipt of which is hereby acknowledged, we hereby grant to THE DETROIT EDISON COMPANY, its successors and assigns, the right to construct, operate and maintain its lines for the transmission and distribution of electricity and Company communication facilities, including the necessary poles, fixtures, guys and guy stubs, wires and equipment, and including also the right to trim or cut down any trees along said lines, which could fall into the lines or interfere in any way with their operation, upon, over and across our property located in the City of Monroe County of Monroe, State of Michigan, and described as follows:

Custer Gardens No. 4 being a part of P.C. 634 and a resubdivision of Lots 102-103  
Custer Gardens No. 3.

The route of the lines shall be as follows:

Along the Southerly 10 feet of lots 105 to 109 inclusive and lots 111 to 113 inclusive; along West 5 feet of lot 109 and East 5 feet of lots 110 and 111; along Northerly 5 feet lots 115 and 116 and Southerly 5 feet of lot 117; along Westerly 5 feet of lots 113 to 115 inclusive and 117 to 137 inclusive; and the Northerly 5 feet of lot 137, 139 and 140; along Northerly 5 feet of lot 134 and Southerly 5 feet of 135 and 136, along Easterly <sup>and Northerly</sup> 5 feet of 138 and Westerly 5 feet of 139 and 140; along Southerly 5 feet and Easterly 5 feet of lot 141; along Easterly 5 feet of lots 142 to 144 inclusive; along Southerly 5 feet of 146 to 148 inclusive; along Northerly and Westerly 5 feet of lot 149; along Easterly 5 feet of lot 148 and lots 150 to 153 inclusive; along Southerly 5 feet and Westerly 5 feet of lot 152 and along Northerly 5 feet of lots 153 to 156 inclusive; along Westerly 5 feet of lot 156; along Easterly 5 feet of lots 157 to 169 inclusive and Westerly 5 feet of 171 to 181 inclusive; along Easterly 5 feet of lots 182 to 192 inclusive; along Southerly 5 feet of 192 to 195 inclusive; and lot 197, along Easterly 5 feet of lot 197; Northerly 5 feet of lots 198 to 203 inclusive. Also, the Westerly 5 feet of North 1/2 of Lot 199.

The Company, its successors and assigns, shall reimburse us for all damage to growing crops, buildings or fences, caused by its men, teams, trucks and other vehicles and equipment in entering said property from time to time for the purposes set forth herein.
