AMENDMENT TO DECLARATION OF RESTRICTIONS

INGLESIDE REALTY COMPANY, a Limited Partnership, of the City of Detroit, Wayne County, Michigan, being the owner of the premises known and described as Lots 195 to 251 inclusive of MORAVIAN GARFIELD SUBDIVISION NO. 4, part of Fractional Section 29, Town 2 North, Range 13 East, Clinton Township, Macomb County, Michigan, according to plat thereof as recorded in Liber 25 of Plats, at Page 47, Macomb County Records, hereby amends the restrictions heretofore imposed upon said premises by a certain Declaration of Restrictions dated the 6th day of November, 1950 and recorded in the office of the Register of Deeds for the County of Macomb on the 15th day of November, 1950, in Liber 811 of Deeds, Page 233.

Paragraph 18 of said Declaration of Restrictions is hereby amended so that the same shall read as follows:

18. A Twelve (12) ft. easement in a Northerly and southerly direction for public utility purposes is hereby granted on each lot in this subdivision starting 170 ft. from the front lot line and ending 182 ft. from the front lot line.
