By acceptance of the right of way granted herein, BUCKEYE PIPE LINE COMPANY, its successors and assigns, agrees to indemnify and save MARATHON OIL COMPANY harmless from any acts, claims, accidents, causes of action, or any legal liability arising from or out of the use of the within right of way.

As further consideration for the granting of the within right of way, BUCKEYE PIPE LINE COMPANY, its successors and assigns, agrees to move the said line promptly at its own cost and expense in the event MARATHON OIL COMPANY chall give notification of its desire to use all or any portion of said right of way for its own corporate purposes.

The term of this right-of-way grant shall be: Twenty-five (25) years.
