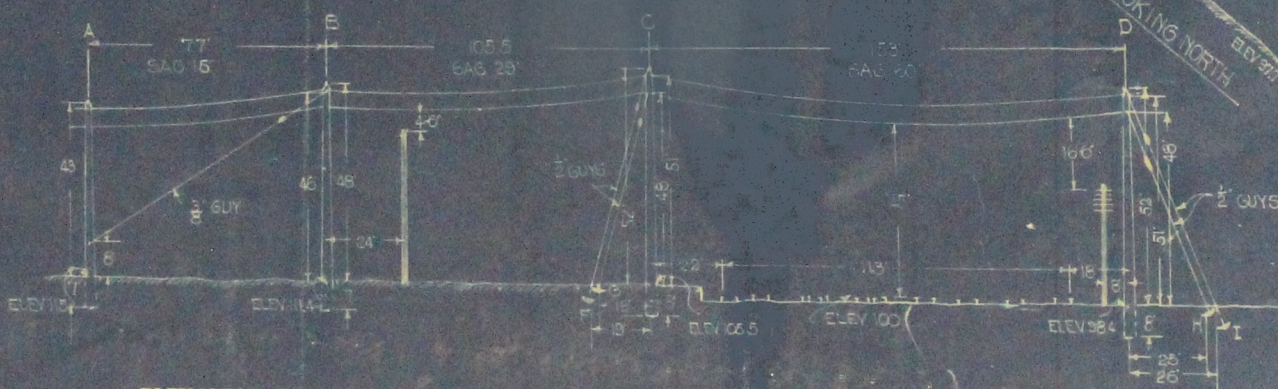

PLAN OF CROSSING



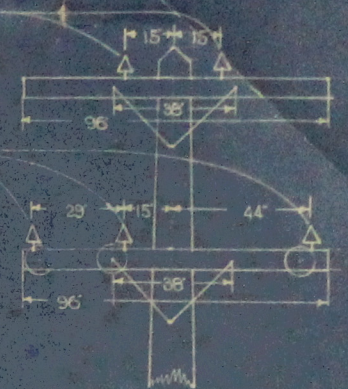
ELEVATION LOOKING NORTH



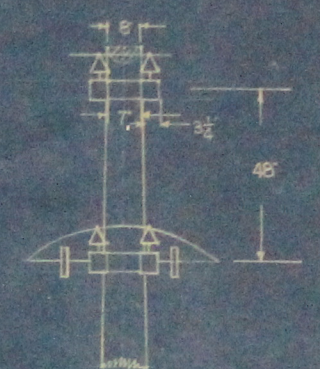
ELEVATION OF CROSSING LOOKING NORTHWEST

PROPOSED 2" 8 CONTROL WIRES (IMMEDIATE)

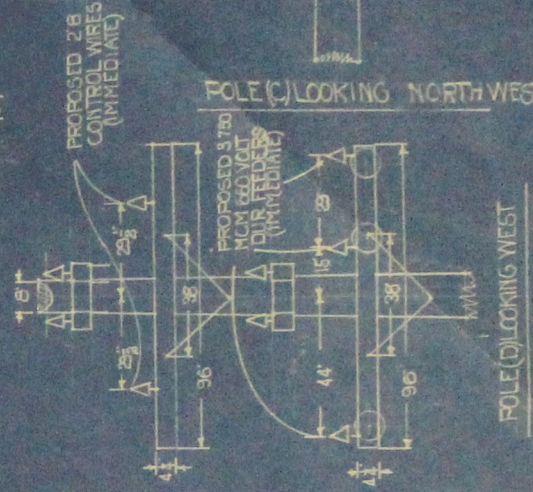
PROPOSED 3 750 MCM 660 VOLT DUR FEEDERS (IMMEDIATE)



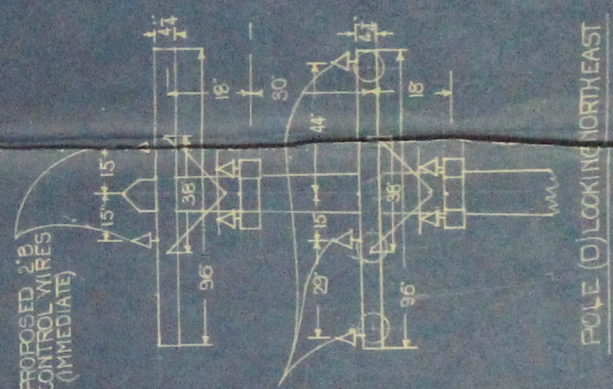
POLE (C) LOOKING NORTH EAST
