The route to be taken by said guy stub anchor pole, guy wires and anchor in, over and across said land is described as follows:

Guy wires to run in an Easterly and Westerly direction from a guy stub anchor pole now located 180 feet North and 60 feet West of the intersection of the centerline of Wilson Avenue, with the centerline of East Boulevard and anchor same in the ground at a point not more than 10 feet Southwesterly of the Northeasterly line of the railroad right of way.
