Michigan Ave., Jackson, Michigan, second party, receipt of which is hereby acknowledged, Convey..... and Warrant..... to the second party, its successors and assigns, Forever, the easement and right to erect, lay and maintain lines consisting of ~~wires~~ poles, wires, cables, conduits and other fixtures and appurtenances for the purpose of transmitting and distributing electricity and/or conducting a communication business on, over, under and across the following described parcel..... of land, including all public highways upon or adjacent to said parcel..... of land, which parcel is situate in the City of Pontiac County of Oakland, and State of Michigan, to-wit: Lot Number eight (8) of Assessor's Plat #53, City of Pontiac, according to the recorded plat thereof, as recorded in Liber 1 of Assessor's Plats, Page 53, Oakland County records.

The route to be taken by said lines of ~~wires~~ poles, wires, cables and conduits across, over and under said land being more specifically described as follows:
Second party may locate said route South of and along and not more than two (2) feet from the North line of said above described Lot.

With full right and authority to the second party, its successors, licensees, lessees or assigns, and its and their agents and employees, to enter at all times upon said premises for the purpose of constructing, repairing, removing, replacing, improving, enlarging and maintaining such cables, conduits and ~~wires~~ poles, poles and other supports, with all necessary braces, guys, anchors, manholes and transformers, and stringing thereon and supporting and suspending therefrom lines of wire, cables or other conductors for the transmission of electrical energy and/or communication, and to trim or remove any tree which at any time may interfere or threaten to interfere with the maintenance of such lines. It is expressly understood that non-use or a limited use of this easement by second party shall not prevent second party from later making use of the easement to the full extent herein authorized.
