- 1. Purpose: The purpose of this Right of Way is to construct, reconstruct, modify, add to, operate and maintain overhead and underground electric transmission line facilities consisting of towers, wood or steel poles, H-frames, wires, conduits, cables, manholes, and fixtures.
- 2. Access: Grantee has the right of access to and from the Right of Way Area.
- 3. Buildings or other Permanent Structures: No buildings or other permanent structures shall be placed in the Right of Way Area without Grantee's prior written consent, which consent shall not be unreasonably withheld.
- 4. Trees, Bushes, Branches or Roots: Grantee may trim, cut down, remove or otherwise control any trees, bushes, branches or roots in the Right of Way Area that Grantee reasonably believes could interfere with the safe and reliable construction, operation and maintenance of Grantee's facilities. Grantee shall nave the light to keep the land thirty feet on each side of the Right of Way Area clear of those trees which Grantee reasonably believes are open may become hazardous to Grantee's facilities.

 Restoration: If Grantee's employees, contractors, vehicles or equipment damage Grantor's Land, buildings, fences or crops while entering Grantor's Land for the purposes stated in this Right of Way, then Grantee shall restore
- 5. Grantor's Land as nearly as can be to its original condition, or at Grantee's option reimburse Grantor for any damage sustained by Grantor.

Successors: This Right of Way runs with the land and binds and benefits Grantor's and Grantee's successors, 6. lessees, licensees, and assigns.
