"Grantor's Land" is in Shelby Township, Macomb County, described as:

PARCEL 1:

Commencing at the east 1/4 post of Section 14, T3N, R12E, thence South 0°44' West 660.0 feet to the point of beginning; thence South 00°44' West 341.10 feet; thence South 89°31'28" West 660.0 feet; thence South 0°44' West 330.0 feet; thence South 89°31'28" West 656.85 feet; thence North 0°33'20" East 676.20 feet; thence North 89°44'52" East 1318.85 feet to the point of beginning, except the North 100.0 feet of the East 660.0 feet.

PARCEL 2:

Being a part of the Southeast 1/4 of Section 14, T3N, R12E, described as follows: Beginning at a point in the East line of Section 14, due North 1320.00 feet from the Southeast corner of said Section 14, and running thence South 88°44' West 660.00 feet to a point; thence North 00°00'53" West 330.0 feet to a point; thence North 88°48' East 660 feet to a point in the East line of Section 14; thence along the East line of Section 14, due South 330 feet to the point of beginning.

PARCEL 3:

The North 100.0 feet of the East 660.0 feet of the following described premises: Commencing at the East 1/4 post of Section 14, T3N, R12E; thence South 0°44' West 660.0 feet to the point of beginning; thence South 0°44' West 341.10 feet; thence South 89°31'28" West 660.0 feet; thence South 0°44' West 330.0 feet; thence South 89°31'28" West 656.85 feet; thence North 0°33'20" East 676.20 feet; thence North 89°44'52" East 1318.85 feet to the point of beginning.

The "Right of Way Area" is a part of Grantor's Land and is described as:

A twelve (12) foot easement being in an easterly and westerly direction along and adjacent to the North property line of the above described property.

ALSO, a twelve (12) foot easement being in an easterly and westerly direction along and adjacent to the South property line of the above described property.

- 1. Purpose: The purpose of this Right of Way is to construct, reconstruct, modify, add to, operate and maintain overhead utility line facilities consisting of poles, guys, anchors, wires, cables, transformers and accessories.
- 2. Access: Grantee has the right of access to and from the Right of Way Area.
- 3. Buildings or other Permanent Structures: No buildings or other permanent structures shall be placed in the Right of Way Area without Grantee's prior written consent.

5. Restoration: If Grantee's employees, contractors, vehicles or equipment damage Grantor's Land while entering Grantor's Land for the purposes stated in this Right of Way, then Grantee

shall restore Grantor's Land as nearly as can be to its original condition.

6. Successors: This Right of Way runs with the land and binds and benefits Grantor's and

Grantee's successors, lessees, licensees and assigns.
