Part of the Northwest 1/4 of Section 35, Ray Township, Macomb County, Michigan, described as: Commencing at the Northwest corner of Section 35; thence South 0 degrees 17 minutes 15 seconds West 521.47 feet along the West Section Line; thence South 52 degrees 36 minutes 25 seconds East 345.98 feet and South 11 degrees 06 minutes 45 seconds East 381.24 feet along the Center Line of Ray Center Road to the point of beginning; thence South 88 degrees 36 minutes 30 seconds East 977.52 feet; thence South 0 degrees 29 minutes 45 seconds West 218.10 feet; thence North 88 degrees 36 minutes 30 seconds West 932.68 feet; thence North 11 degrees 06 minutes 45 seconds West 223.40 feet along the Center Line of Ray Center Road to the point of beginning, 4.80 acres of land, more or less. The "Right of Way Area" is a part of Grantor's Land and is described as:

Across the South ten (10') feet of the West Sixty-five (65') feet of the above described land; also, the East ten (10') feet of the Westerly forty-three (43') feet of Grantor's land.

- **1. Purpose:** The purpose of this Right of Way is to construct, reconstruct, modify, add to, operate and maintain overhead utility line facilities consisting of poles, guys, anchors, wires, cables, transformers and accessories.
- 2. Access: Grantee has the right of access to and from the Right of Way Area.
- **3. Buildings or other Permanent Structures:** No buildings or other permanent structures shall be placed in the Right of Way Area without Grantee's prior written consent.
- 4. Trees, Bushes, Branches or Roots: Grantee may trim, cut down, remove or otherwise control any trees, bushes, branches or roots in the Right of Way Area (or that could grow into the Right of Way Area) that Grantee believes could interfere with the safe and reliable construction, operation and maintenance of Grantee's facilities.
- **5. Restoration:** If Grantee's employees, contractors, vehicles or equipment damage Grantor's Land while entering Grantor's Land for the purposes stated in this Right of Way, then Grantee shall restore Grantor's Land as nearly as can be to its original condition.
- **6. Successors:** This Right of Way runs with the land and binds and benefits Grantor's and Grantee's successors, lessees, licensees and assigns.
