The Detroit Edison Company, a Michigan corporation, 2000 Second Avenue, Detroit, Michigan 48226

### "Grantor's Land" is in Elba Township, Lapeer County, Michigan described as:

Section 16, T7N-R9E, Beginning at a point 1319.18 feet South and 75.33 feet West of the North 1/4 corner; thence South 583.48 feet; thence South 68°24'35" West 255.82 feet; thence South 21°35'25" East 20 feet; thence 68°24'35" West 1085.73 feet; thence North 820.08 feet; thence East 470.23 feet; thence North 190 feet; thence East 778.74 feet to the point of beginning.

The "Right of Way Area" is a part of Grantor's Land and is described  $\Gamma$ as:

A 12' wide easement as shown on Exhibit "A", which is attached hereto and made a part hereof.

- 1. Purpose The purpose of this Right of Way is to construct, reconstruct, modify, add to, operate and maintain overhead utility line facilities consisting of poles, guys, anchors, wires, cables, transformers and accessories.
- 2. Access Grantee has the right of access to and from the Right of Way Area.
- 3. Buildings or other Permanent Structures No buildings or other permanent structures shall be placed in the Right of Way Area without Grantee's prior written consent.
- 4. Trees, Bushes, Branches or Roots Grantee may trim, cut down, remove or otherwise control any trees, bushes, branches or roots in the Right of Way Area (or that could grow into the Right of Way Area) that Grantee believes could interfere with the safe and reliable construction, operation and maintenance of Grantee's facilities.
- 5. Restoration If Grantee's employees, contractors, vehicles or equipment damage Grantor's Land while entering Grantor's Land for the purposes stated in this Right of Way, then Grantee shall restore Grantor's Land as nearly as can be to its original condition.
- 6. Successors This Right of Way runs with the land and binds and benefits Grantor's and Grantee's successors, lessees, licensees and assigns.
