

## OVERHEAD EASEMENT (RIGHT OF WAY) NO. 15342/2

On Nov 29, 1995, for the consideration of system betterment, Grantor grants to Grantee a permanent overhead easement ("Right of Way") in, on and across a part of Grantor's Land called the "Right of Way Area".

PARCEL "E":

PART OF THE NORTHEAST FRACTIONAL 1/4 OF SECTION 5, T8N-R10E, described as beginning at a point on the North section line that is North 88°53'05" East 1293.32 feet from the North 1/4 corner of Section 5; thence continuing along said North section line, North 88°53'05" East 66.00 feet; thence South 01°31'20" Est 16037feet along an occupied line to the South line of the North fractional 1/2 of the Northeast fractional 1/4, as occupied; thence North 89°42'31" West 1353.89 feet along said South line to the North-South 1/4 line of Section 5; thence North 01°44'38" West 370.56 feet along said North-South 1/4 line; thence North 88°53'05" East 1288.57 feet; thence North 01°31'20" West 1199.97 feet to the point of beginning. CONTAINS 13.851 ACRES, including that part reserved for Norway Lake Road so-called. Seing subject to any restrictions, easements and/or right of ways of record. ALSO SUBJECT TO A 15.00 FOOT WIDE UTILITY EASEMENT OVER & ACROSS THE SOUTH 15.00 FEET OF THE NORTH 48.00 FEET THEREOF.

The "Right of Way Area" is a part of Grantor's Land and is described as:

A 12' wide easement as shown on Exhibit "A", which is attached hereto and made a part hereof.

- 1. Purpose The purpose of this Right of Way is to construct, reconstruct, modify, add to, operate and maintain overhead utility line facilities consisting of poles, guys, anchors, wires, cables, transformers and accessories.
- 2. Access Grantee has the right of access to and from the Right of Way Area.
- 3. Buildings or other Permanent Structures No buildings or other permanent structures shall be placed in the Right of Way Area without Grantee's prior written consent.
- 4. Trees, Bushes, Branches or Roots Grantee may trim, cut down, remove or otherwise control any trees, bushes, branches or roots in the Right of Way Area (or that could grow into the Right of Way Area) that Grantee believes could interfere with the safe and reliable construction, operation and maintenance of Grantee's facilities.
- 5. Restoration If Grantee's employees, contractors, vehicles or equipment damage Grantor's Land while entering Grantor's Land for the purposes stated in this Right of Way, then Grantee shall restore Grantor's Land as nearly as can be to its original condition.
- 6. Successors This Right of Way runs with the land and binds and benefits Grantor's and Grantee's successors, lessees, licensees and assigns.


