


OVERHEAD EASEMENT (RIGHT OF WAY) NO. 24885/2

On 12/21, 1995, for the consideration of system betterment, Grantor grants to Grantee a
permanent overhead easement ("Right of Way") in, on and across a part of Grantor's Land called the
"Right of Way Area".
"Grantor" is: Jesus A. Garcia and Christine M. Garcia, husband and wife, 206 W. Coulter Rd., Lapeer, MI 48446 "Grantee" is:
The Detroit Edison Company, a Michigan corporation, 2000 Second Avenue, Detroit, Michigan 48226
"Grantor's Land" is in Mayfield Township, Lapeer County, Michigan described as:
The South 20 acres of the West 1/2 of the West 1/2 of the Southeast 1/4 of Section 8, T8N-R10E, EXCEPT
commencing at the Southeast corner of the West 1/2 of the West 1/2 of the Southeast 1/4 of said Section
8; thence West 4 rods; thence North 20 rods parallel with the East Section line; thence East 4 rods; thence South to the place of beginning.
The "Right of Way Area" is a part of Grantor's Land and is described
as:
A 12' wide easement as shown on Exhibit "A", which is attached hereto and made a part hereof.
1. Purpose The purpose of this Right of Way is to construct, reconstruct, modify, add to, operate and maintain overhead utility line facilities consisting of poles, guys, anchors, wires, cables, transformers
and accessories.
2. Access Grantee has the right of access to and from the Right of Way Area.
3. Buildings or other Permanent Structures No buildings or other permanent structures shall be placed in the Right of Way Area without Grantee's prior written consent.
4. Trees, Bushes, Branches or Roots Grantee may trim, cut down, remove or otherwise control any
trees hishes branches or roots in the Right of Way Area (or that early grow into the Right of Way
Area) that Grantee believes could interfere with the safe and reliable construction, operation and
maintenance of Grantee's facilities. 5. Restoration If Grantee's employees, contractors, vehicles or equipment damage Grantor's Land while
entering Grantor's Land for the purposes stated in this Right of Way, then Grantee shall restore
