

OVERHEAD EASEMENT (RIGHT OF WAY) NO. 48822
On, 1996, for the consideration of system betterment, Grantor grants to Grantee a permanent overhead easement ("Right of Way") in, on and across a part of Grantor's Land called the "Right of Way Area".  "Grantor" is:

"Grantor's Land" is in Oregon Township, Lapeer County, Michigan described as:  Part of the Southeast 1/4 of Section 2, T8N-R9E, described as: Beginning at a point that is North 1321.40 feet and North 89°56'45" West 1319.85 feet and North 00°24'01" East 1317.80 feet from the East 1/4 corner of Section 11, T8N-R9E; thence South 89°40'42" East 515 feet; thence North 00°19'18" East 613 feet; thence North 89°40'42" West 1007.43 feet; thence South 38°27'13' East 786.29 feet to the place of beginning.  The "Right of Way Area" is a part of Grantor's Land and is described as:  A 12' wide easement as shown on Exhibit "A", which is attached hereto and made a part hereof.  1. Purpose The purpose of this Right of Way is to construct, reconstruct, modify, add to, operate and maintain overhead utility line facilities consisting of poles, guys, anchors, wires, cables, transformers and accessories.  2. Access Grantee has the right of access to and from the Right of Way Area.  3. Buildings or other Permanent Structures No buildings or other permanent structures shall be placed in the Right of Way Area without Grantee's prior written consent.  4. Trees, Bushes, Branches or Roots Grantee may trim, cut down, remove or otherwise control any trees, bushes, branches or roots in the Right of Way Area (or that could grow into the Right of Way Area) that Grantee believes could interfere with the sa and reliable construction, operation and maintenance of Grantee's facilities.  5. Restoration If Grantee's employees, contractors, vehicles or equipment damage Grantor's Land while entering Grantor's Land for the purposes stated in this Right of Way, then Grantee shall restore Grantor's Land as nearly as can be to its original condition.  6. Successors This Right of Way runs with the land and binds and benefits Grantor's and Grantee's successors, lessees, licensee and assigns.
