"Grantor's Land" is in Mayfield Township, Lapeer County, Michigan described as:

Part of the Northeast ¼ of Section 34 and part of the Northwest ¼ of Section 35, T8N-R10E, Mayfield Township, Lapeer County, Michigan, described as beginning at a point on the North line of Section 35 that is North 89° 59' 24" East 300.00' from the Northwest corner of Section 35, thence continuing North 89° 59' 24" East 66.00' along the North line of Section 35, thence South 00° 02' 26" West 2654.29' to the East-West ¼ line of Section 35, thence North 89° 48' 40" West 366.00' along said East-West ¼ line to the West ¼ corner of Section 35, thence North 00° 02' 26" East 675.39' along the West line of Section 35, thence North 89° 37' 52" West 660.57', thence North 00° 01' 59" East 1317.63', thence South 89° 37' 52" East 660.74', thence South 00° 02' 26" West 68.00' along the West line of Section 35, thence North 89° 59' 24" East 300.00', thence North 00° 02' 26" East 728.00' to the point of beginning. Contains 37.267 acres, including that part reserved for Haines Road so-called. Being subject to any restrictions, easements and/or right of ways of record.

The "Right of Way Area" is a part of Grantor's Land and is described as: A 12' wide easement and a 32' wide easement as shown on Exhibit "A", which is attached hereto and made a part hereof.

- 1. Purpose: The purpose of this Right of Way is to construct, reconstruct, modify, add to, operate and maintain underground utility line facilities consisting of poles, guys, anchors, wires, manholes, conduits, pipes, cables, transformers and accessories.
- 2. Access: Grantee has the right of access to and from the Right of Way Area.
- **3. Buildings or other Permanent Structures:** No buildings or other permanent structures are allowed in the Right of Way Area without Grantee's prior written consent.
- **4. Excavation:** Under 1974 Public Act 53, you must call MISS DIG (1-800-482-7171) before excavating in the Right of Way Area.
- 5. Trees, Bushes, Branches, Roots, Structures and Fences: Grantee may trim, cut down, remove or otherwise control any trees, bushes, branches and roots in the Right of Way Area (or that could grow into the Right of Way Area) and remove structures and fences in The Right of Way Area that Grantee believes could interfere with the safe and reliable construction, operation and maintenance of Grantee's facilities. No trees, plant life, structures and fences can be planted, grown or installed within 8 feet of the front door and within 2 feet of the other sides of transformers and switching cabinet enclosures. Grantee will not be responsible to Grantor for damages to or removal of trees, plant life, structures and fences placed in front of transformer doors.
- **6. Restoration:** If Grantee's employees, contractors, vehicles or equipment damage Grantor's Land while entering Grantor's Land for the purposes stated in this Right of Way, then Grantee will restore Grantor's Land as nearly as can be to its original condition.
