WHEREAS, OWNERS have requested that EDISON partially release and limit its rights pursuant to said license dated June 12, 1935, and EDISON is willing to do so.

NOW THEREOFRE, in consideration of the sum of One (\$1.00) Dollar and other valuable considerations, receipt of which is hereby acknowledged, EDISON does, by these presents, and subject to the conditions hereinafter stated, release, quit claim and abandon onto OWNERS, their heirs, administrators, successors and assigns, all of the rights to which it has succeeded, excepted as stated below, under the aforementioned license as they may pertain to that part of the lands last

- (1) Notwithstanding the terms and conditions contained in the aforementioned license, EDISON shall have the perpetual right to reconstruct, modify, repair and maintain its lines and equipment for the transmission and distribution of electricity and company communication facilities and OWNERS shall not erect or place any buildings or structures within the premises excepted from this partial release.
- (2) Subject to the conditions herein contained, in all respects, excepted as to the extent hereby released, the aforementioned license dated June 12, 1935, shall and does remain in full force and effect.
