Michigan Ave., Jackson, Michigan, second party, receipt of which is hereby acknowledged, Convey and Warrant to the second party, its successors and assigns. Forever, the easement and right to erect, lay and maintain lines consisting of ~~trans~~ poles, wires, cables, conduits and other fixtures and appurtenances for the purpose of transmitting and distributing electricity and/or conducting a communication business on, over, under and across the following described parcel .s. of land, including all public highways upon or adjacent to said parcel .s. of land, which parcel .s. are situate in the Township of Grant County of Cheboygan, and State of Michigan, to-wit:

The Southwest 1/4 of the Northeast 1/4 of Sec. 6; the North 1/2 of the Southeast 1/4 of Sec. 6; the Southeast 1/4 of the Southeast 1/4 of Sec. 6; the Northeast 1/4 of the Southwest 1/4 of Sec. 6 and so much of the Southeast 1/4 of the Northwest fractional 1/4 of Sec. 6, as is included and occupied by a certain line fence, excepting therefrom a parcel of land in the Northwest cor. of the Southwest 1/4 of the Northeast 1/4 of sd. Sec. 6, being now or formerly owned by Steve Lafrinere, being all in Township 36 North, Range 1 East.

The route to be taken by said lines of ~~trans~~ poles, wires, cables and conduits across, over and under said land being more specifically described as follows:

Should the Second Party at any time abandon or discontinue the use of the contemplated electrical transmitting lines, it shall within ninety (90) days thereof deliver to the parties of the first part, their heirs, legal representatives or assigns, a good and sufficient recordable Quit Claim Deed relinquishing the within right of way easement.

It is expressly understood that no buildings or other structures will be placed under such wires and/or over such cables without the written consent of said second party. It is expressly understood that non-use or a limited use of this easement by second party shall not prevent second party from later making use of the easement to the full extent herein authorized. Second party to pay at the rate of Eighty Dollars (\$80.00) per mile of length of the line of poles and wires across said above described premises, the same to be paid before any work is done on the land, and also to pay for any damage to crops in erecting and maintaining said line of poles and wires.
