The Southwest one-quarter (1/4) of the Southeast one-quarter (1/4) of Section thirty-six (36), Township thirty-seven (37) North, Range one (1) West, excepting therefrom the East twenty-five (25) rods of the South fifteen (15) rods thereof. ALSO: All that part of the South one-half (1/2) of the Southwest one-quarter (1/4) of Section thirty-six (36), Township thirty-seven (37) North, Range one (1) West, lying Easterly of Black River Hwy., so-called.

The route to be taken by said lines of poles, wires, cables and conduits across, over and under said land being more specifically described as follows: Second party may locate said route on, over and across said above described land, along or adjoining as near as practicable a line, which said line is described as beginning at a point not more than 1800 feet nor less than 1200 feet West of the North and South quarter line of Section 36, Township 37 North, Range 1 West...
