All that part of the North one-half (1/2) of the Southwest one-quarter (1/4) of Section twenty-seven (27), Township thirty-seven (37) North, Range one (1) West, lying Southwesterly of Black River Road, so-called.

The route to be taken by said lines of ~~wood~~ poles, wires, cables and conduits across, over and under said land being more specifically described as follows: Sec. party may loc. said rte. on, over and across said above desc. land, along or adjoining as near as pract. a line, which said line is desc. as beg. at a point not more than 800 ft. nor less than 500 ft. West of the East line of Sec. 29, T37N, R1W, at a point not more than 1500 ft. nor less than 1100 ft. South of the North line of said Sec., running thence Southeasterly to a point not more than 2000 ft. nor less than 1600 ft. With full right and authority to the second party, its successors, licensees, lessees or assigns, and its and their agents and employees, to enter at all times upon said premises for the purpose of constructing, repairing, removing, replacing, patrolling, improving, enlarging and maintaining such cables, conduits and ~~wood~~ poles and other supports, with all necessary braces, guys, anchors, manholes and transformers, and stringing thereon and supporting and suspending therefrom lines of wire, cables or other conductors for the transmission of electrical energy and/or communication, and to trim, remove, destroy or otherwise control any trees and brush which may, in the opinion of said second party, interfere or threaten to interfere with or be hazardous to the construction, operation and maintenance of said lines.
