first part 1st, in consideration of One Dollar (\$1.00) to them
paid by the CONSUMERS POWER COMPANY, a Maine corporation authorized to do business in Michigan, at 212 W. Michigan Ave.,
Jackson, Michigan, second party, receipt of which is hereby acknowledged. Convey and Warrant to the second party, its
successors and assigns, Forever, the easement and right to erect, lay and maintain lines consisting of ~~wooden~~ poles, wires, cables,
conduits and other fixtures and appurtenances for the purpose of transmitting and distributing electricity and/or conducting a com-
munication business on, over, under and across the following described parcel of land, including all public highways upon or
adjacent to said parcel of land, which parcel is situate in the Township of Inverness County
of Cheboygan and State of Michigan, to-wit:

The East one-half (1/2) of the West one-half (1/2) of the Southeast one-quarter (1/4) of Section
twenty-eight (28), Township thirty-seven (37) North, Range two (2) West, excepting therefrom
a parcel of land two hundred (200) feet North and South by two hundred twenty (220) feet East
and West out of the Southeast corner thereof.

The route to be taken by said lines of ~~wooden~~ poles, wires, cables and conduits across, over and under said land being more specif-
ically described as follows: Sec. pty. may locate said route on, over and across sd. above desc. land,
alg. or adj. as near as pract. a line, which said line is desc. as beginning on the West line
of Sec. 32, T37N, R2W, at a point not more than 450 ft. South of the West quarter post of
said Sec., running thence East to a point not more than 2200 feet nor less than 1800 feet
from the West line of said Sec. 32, at a point not more than 450 feet South of the East and
West quarter line of said Sec., running thence Northeasterly to a point not more than 750 feet
nor less than 450 feet West of the East line of Sec. 28 of sd. Twp., at a point not more than
1000 feet nor less than 700 feet North of the East and West quarter line of said Sec. 28.

With full right and authority to the second party, its successors, licensees, lessees or assigns, and its and their agents and employees,
to enter at all times upon said premises for the purpose of constructing, repairing, removing, replacing, patrolling, improving,
enlarging and maintaining such cables, conduits and ~~wooden~~ poles and other supports, with all necessary braces, guys, anchors
manholes and transformers, and stringing thereon and supporting and suspending therefrom lines of wire, cables or other conductors
for the transmission of electrical energy and/or communication, and to trim, remove, destroy or otherwise control any trees and
brush which may, in the opinion of said second party, interfere or threaten to interfere with or be hazardous to the construction,
operation and maintenance of said lines. It is expressly understood that no buildings or other structures will be placed under such
wires and/or over such cables without the written consent of said second party. It is expressly understood that non-use or a limited
use of this easement by second party shall not prevent second party from later making use of the easement to the full extent herein
authorized. Second party to pay at the rate of Eighty Dollars (\$80.00) per mile of length of
the line of poles and wires across said above described premises, the same to be paid before
any work is done on the land, and also to pay for any damage to crops in erecting and main-
taining said line of poles and wires.
