The North one-half (1/2) of the Southwest one-quarter (1/4) of Section thirty-one (31), Township thirty-seven (37) North, Range two (2) West, excepting therefrom a parcel of land containing one (1) acre out of the Southwest corner thereof...

The route to be taken by said lines of poles, wires, cables and conduits across, over and under said land being more specifically described as follows:

Second party may locate said route South of and not more than 450 feet from the center line of the Highway on the North side of said above described land; also conveying the right to erect and maintain lines of poles and wires leading laterally from said route to the North line of said land.

With full right and authority to the second party, its successors, licensees, lessees or assigns, and its and their agents and employees, to enter at all times upon said premises for the purpose of constructing, repairing, removing, replacing, patrolling, improving, enlarging and maintaining such cables, conduits and poles and other supports...
