The North one-half (1/2) of the Northeast one-quarter (1/4) of Section Thirty-six (36), Township Thirty-seven (37) North, Range Three (3) West, excepting a parcel of land containing one (1) acre out of the Northeast corner thereof

The route to be taken by said lines of poles, wires, cables and conduits across, over and under said land being more specifically described as follows: Second party may locate said route West of and not more than 700 feet nor less than 600 feet from the centerline of the Highway on the East side of said above described land...

Subject to certain conditions appearing on the reverse side hereof which are incorporated herein by reference.

With full right and authority to the second party, its successors, licensees, lessees or assigns, and its and their agents and employees, to enter at all times upon said premises for the purpose of constructing, repairing, removing, replacing, improving, enlarging and maintaining such cables, conduits and poles, poles and other supports, with all necessary braces, guys, anchors, transformers, and stringing thereon and supporting and suspending therefrom lines of wire, cables or other conductors...

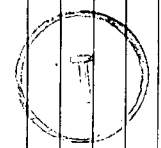
