Forever, the easement and right to erect, lay and maintain lines consisting of ~~poles~~, poles, wires, cables, conduits and other fixtures and appurtenances for the purpose of transmitting and distributing electricity and/or conducting a communication business on, over, under and across the following described parcel... of land, including all public highways upon or adjacent to said parcel... of land, which parcel... is... situate in the... Township of... Munro... County of... Cheboygan... and State of Michigan, to-wit:
 The North one-half (1/2) of the North one-half (1/2) of the Southeast one-quarter (1/4) of Section twenty-four (24), Township thirty-seven (37) North, Range three (3) West.
