Convey and Warrant to the second party, its successors and assigns, forever, the easement and right to erect, lay and maintain lines consisting of poles, wires, cables, conduits and other fixtures and appurtenances for the purpose of transmitting and distributing electricity and/or conducting a communication business on, over, under and across the following described parcel of land, including all public highways upon or adjacent to said parcel of land, which parcel is situate in the Township of Hebron County of Cheboygan and State of Michigan, to-wit: The East one-half (1/2) of the Northeast one-quarter (1/4) of Section ten (10), Township thirty-eight (38) North, Range three (3) West.

The route to be taken by said lines of poles, wires, cables and conduits across, over and under said land being more specifically described as follows: Second party may locate said route on, over and across said above described land, along or adjoining as near as practicable a line, which said line is described as beginning on the East and West quarter line of Section 10, Township 38 North, Range 3 West, at a point not more than 600 feet nor less than 400 feet West of the East line of said Section, running thence Northerly to a point not more than 600 feet nor less than 400 feet West of the East line of said Section, at a point not more than 400 feet nor less than 200 feet South of the North line of said Section, thence Northwesterly to a point not more than 200 feet West of the North and South quarter line of section 3 of said township, at a point not more than 300 feet nor less than 100 feet North of the East and West quarter line of said Section 3.

With full right and authority to the second party, its successors, licensees, lessees or assigns, and its and their agents and employees, to enter at all times upon said premises for the purpose of constructing, repairing, removing, replacing, patrolling, improving, enlarging and maintaining such cables, conduits and other supports, with all necessary braces, guys, anchors, manholes and transformers, and stringing thereon and supporting and suspending therefrom lines of wire, cables or other conductors for the transmission of electrical energy and/or communication, and to trim, remove, destroy or otherwise control any trees and brush which may, in the opinion of said second party, interfere or threaten to interfere with or be hazardous to the construction, operation and maintenance of said lines.
