EASEMENT TO CONSTRUCT AND MAINTAIN ELECTRIC TRANSMISSION LINE

FOR AND IN CONSIDERATION OF One hundred twenty eight and no/100 Dollars (\$128.00) in hand paid, the receipt of which is hereby acknowledged, the DEPARTMENT OF CONSERVATION for the STATE OF MICHIGAN does hereby Convey and Quit-Claim to Consumers Power Company a corporation, whose post office address is 212 W. Michigan Ave., Jackson, Michigan and to its successors and assigns, the easement and right to erect and maintain an electric transmission line consisting of poles, structures, wires, cables and conduits, together with anchors, guy wires and other appurtenances and fixtures necessary for the purpose of transmitting and distributing electricity and/or conducting a communication business, together with the right to go upon the land herein described and maintain same on, over and across the following State-owned land:

Land in the Township of Mackinaw County of Cheboygan, State of Michigan, as follows, to-wit:

The South one-half (1/2) of the Southeast one-quarter (1/4) of Section thirty-two (32); the West one-half (1/2) of the Northwest one-quarter (1/4) of Section thirty-two (32), and the Southeast one-quarter (1/4) of the Northwest one-quarter (1/4) of Section thirty-two (32), all being in Township thirty-nine (39) North, Range three (3) West.

This easement is granted subject to the following regulations and conditions:

(1) The route to be taken by said line of poles, structures, wires, cables and conduits across, over and under said land being more specifically described as follows: Second party may locate said route on, over and across said above described land, along or adjoining as near as practicable a center line, which said center line is described as beginning on the South line of Section 32, Township 39 North, Range 3 West, at a point approximately 1075 feet East of the North and South quarter line of said Section, running thence Northwesterly to a point approximately 720 feet East of the North and South quarter line of said Section at a point approximately 218 feet North of the South line of said Section, thence Northwesterly to the West line of said Section at a point approximately 100 feet South of the North line of said Section.
