Section 33, Township 25 North, Range 3 West, excepting therefrom the North 500 feet thereof.also excepting all that part of the Southwest 1/4 lying South and West of the right-of-way of US-27, formerly known as State Trunk Line Highway M-14 also excepting therefrom US-27 right-of-way.

The complete exercise of the rights herein granted to cut, trim, remove, destroy or otherwise control trees and brush may be gradual and not fully completed for some time in the future, and Grantee may enter upon said land, from time to time and at no additional cost to Grantee, to cut, trim, remove, destroy or otherwise control trees and brush as aforesaid. Grantor agrees that, for the protection of said facilities, no buildings or other structures will be placed within feet on each side of the center line of said line of towers, pole structures or poles. Grantee shall pay for all damage to crops arising out of the construction, operation and maintenance of said facilities. Nonuse of a limited use of this easement by Grantee shall not prevent Grantee from later making use of the easement to the full extent herein conveyed.
