Department of Conservation for the State of Michigan, by P. J. Hoffmaster, Director, first party, consideration of One Dollar (\$1.00) to it paid by the CONSUMERS POWER COMPANY...

The West three-quarters (3/4) of the North one-half (1/2) of the North one-half (1/2); the East three-quarters (3/4) of the South one-half (1/2) of the North one-half (1/2) and the Northeast one-quarter (1/4) of the Southeast one-quarter (1/4) of Section 1, Township 28 North, Range 1 West.

As a further consideration for the issuance of this easement Consumers Power Company agrees to notify the Department's authorized representative prior to commencing operations under this easement.

It is understood that any relocation of a line constructed under this easement will require the approval of the Department of Conservation.

It is understood and agreed that in the event this electric pole line is abandoned for a period of one year the rights granted herein are to cease and be of no effect.

The route to be taken by said lines of poles, wires, cables and conduits across, over and under said land being more specifically described as follows: Second party may locate said route on, over and across said above described land within 50 feet on either side of a line, which said line is described as beginning at a point approximately 100 feet East of the West line of Section 35, Township 29 North, Range 1 West...

With full right and authority to the second party, its successors, licensees, lessees or assigns, and its and their agents and employees, to enter at all times upon said premises for the purpose of constructing, repairing, removing, replacing, improving, enlarging and maintaining such cables, conduits and poles and other supports, with all necessary braces, guys, anchors, manholes and transformers...

Second party to pay at the rate of Eighty Dollars (\$80.00) per mile of length of the line of poles and wires across said above described premises, the same to be paid before any work is done on the land. All commercial forest products cut from the right of way shall be the property of the Department of Conservation and shall be cut and piled as directed by its Field Representative.
