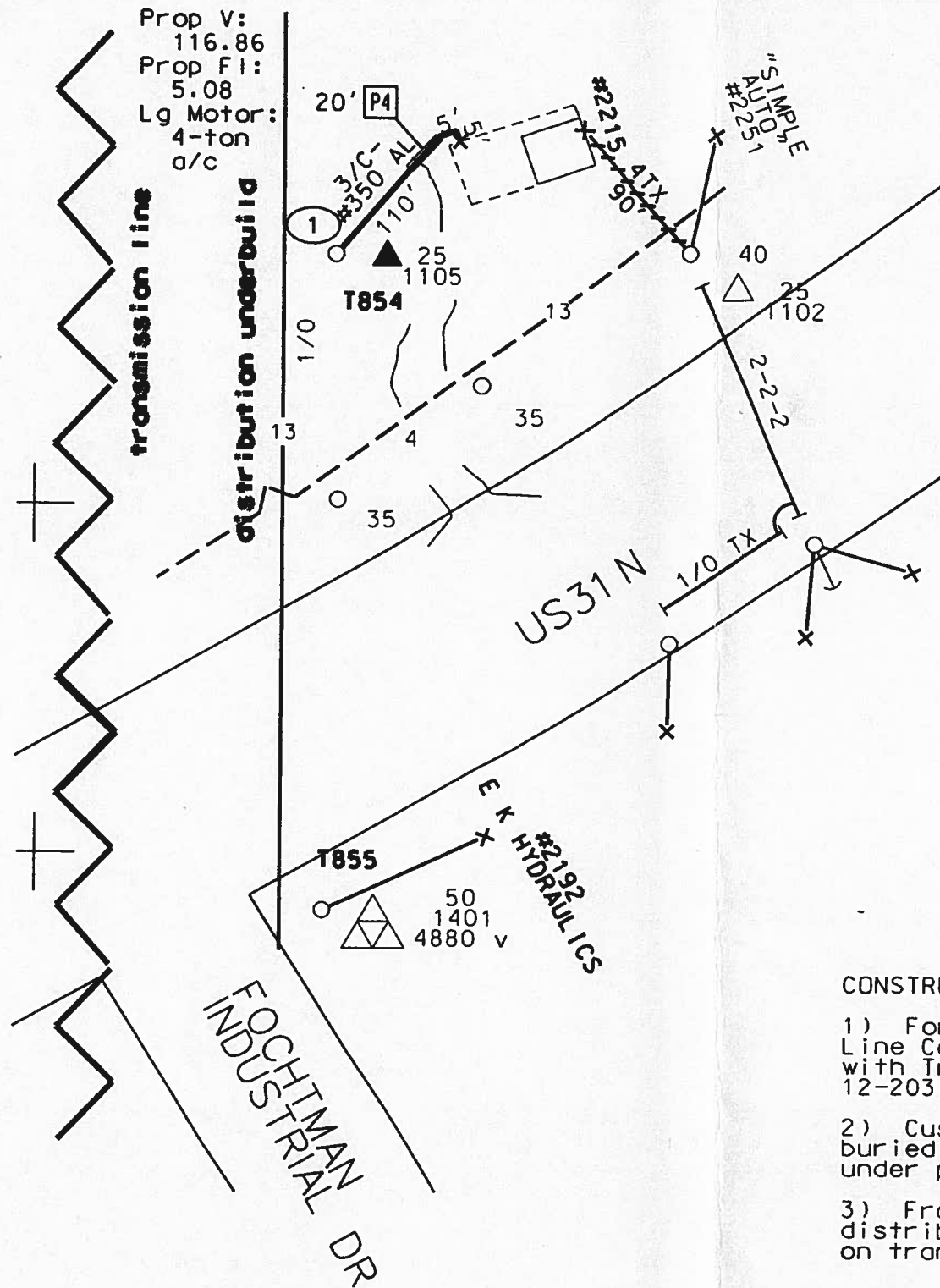
Subject: Three Phase, 25 KVA Transformer & Underground Distribution Line.

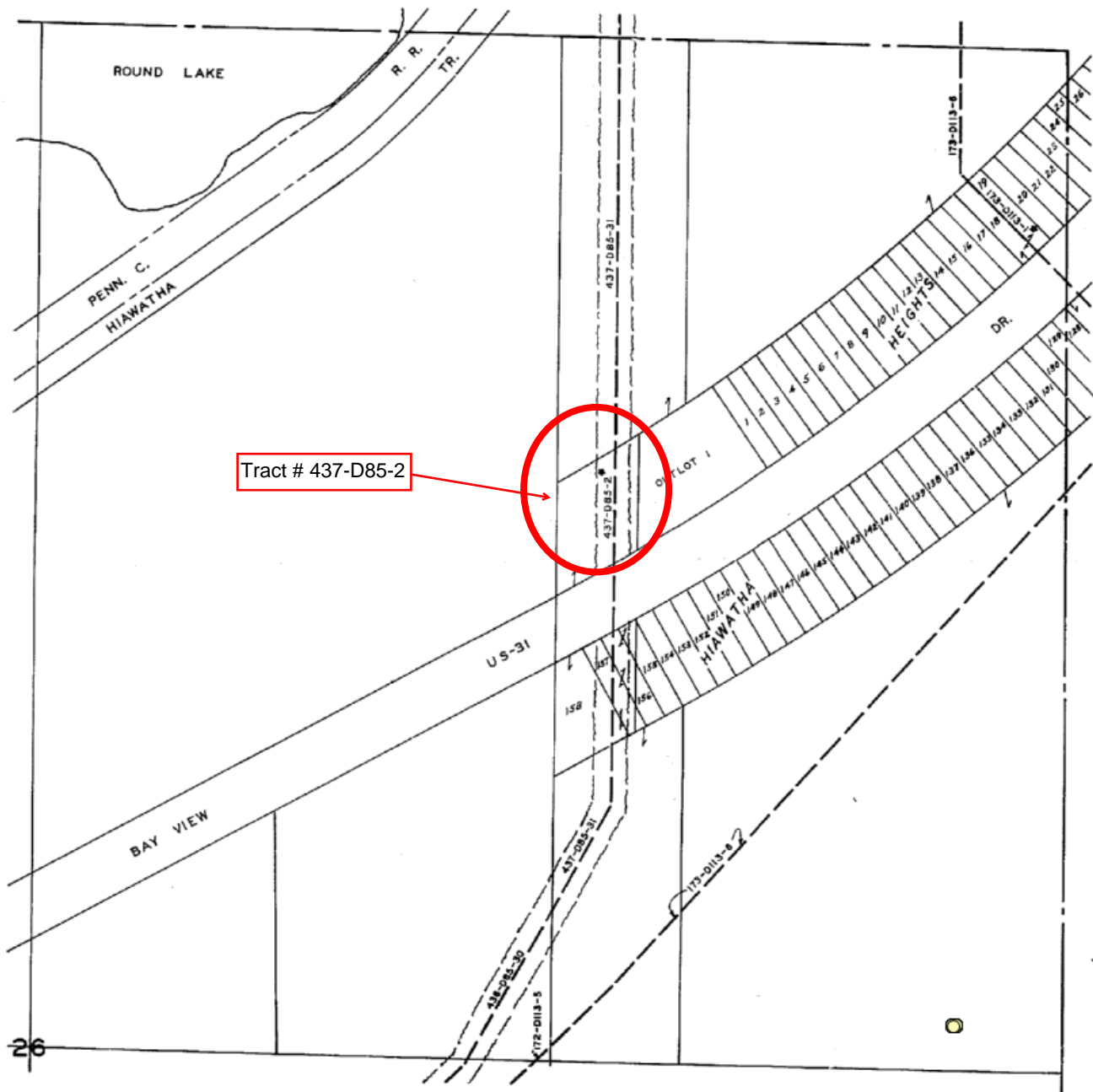

- 3) From Serviceman's measurements, 3-ph primary distribution underbuild is @ 36'6" on transmission pole.

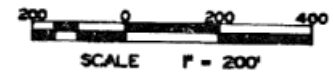
