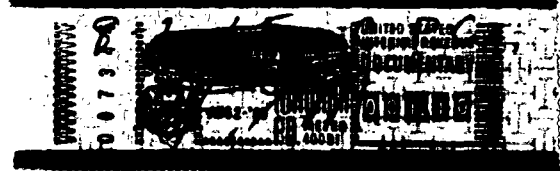
WITNESSETH:
