The Northeast one-quarter (1/4) of the Northeast one-quarter (1/4) of Section seven (7), Township eighteen (18) North, Range two (2) West, excepting therefrom a parcel of land out of the Northeast corner now or formerly owned by the West Grout Methodist Episcopal Church of Gladwin, Michigan.

The route to be taken by said lines of poles, wires, cables and conduits across, over and under said land being more specifically described as follows: Second party may locate said route in a Northerly and Southerly direction on, over and across said above described land Westerly of and along and not more than 800 feet nor less than 600 feet from the center line of the highway on the East side of said land.

With full right and authority to the second party, its successors, licensees, lessees or assigns, and its and their agents and employees, to enter at all times upon said premises for the purpose of constructing, repairing, removing, replacing, improving, enlarging and maintaining such cables, conduits and poles and other supports, with all necessary braces, guys, anchors, manholes and transformers...
