EASEMENT

Charles D. Muma and Irene E. Muma, also known as Irene F. Muma, his wife, 1164 W. First Street Gladwin, Michigan, and Christopher L. Muma and Linda S. Muma, his wife, 1154 W. First Street, Gladwin, Michigan.

Grantor, in consideration of One and no/100 Dollars (\$ 1.00), paid by CONSUMERS POWER COMPANY, a Michigan corporation, 212 W. Michigan Avenue, Jackson, Michigan, Grantee, the receipt of which is hereby acknowledged, CONVEYS and WARRANTS to Grantee, its successors and assigns, the easement and right to erect and maintain guy stub anchor pole, guy wires and anchor on, over and across the following described parcel, of land in the City of Gladwin County of Gladwin and State of Michigan, to-wit:

The South 125 feet of the East 660 feet of the Southwest 1/4 of the Southwest 1/4 of Section 36, Township 19 North, Range 2 West, except a parcel described as beginning at a point on the South line of Section 36, Township 19 North, Range 2 West, which is North 89° 15' West 1547.24 feet from the South 1/8 corner of said section, thence North 0° 45' East 150 feet, thence North 89° 15' West 80 feet, thence South 0° 45' West 150 feet to the South line of said section, thence South 89° 15' East along said section line 80 feet to the point of beginning.

The route to be taken by said guy stub anchor pole, guy wires and anchor across said land being more specifically described as follows:

Guy wires to run in a Northerly direction from a pole to be located not more than 30 feet North of the South line of Section 36, T 19 N, R 2 W, at a point not more than 420 feet nor less than 400 feet West of the West 1/8 line of said section and anchor same in the ground at a point not more than 75 feet North of said pole. Also guy wires to run in a Northerly direction from a pole to be located at a point 8 feet South of the North line of First Street, Section 36, T 19 N, R 2 W, at a point not more than 10 feet West of the West 1/8 line of said section to a guy stub anchor pole to be located at a point not more than 50 feet North of the South line of said section at a point not more than 10 feet West of the West 1/8 line of said section and anchor same in the ground at a point not more than 100 feet North of the South line of said section at a point not more than 5 feet West of the West 1/8 line of said section.

Together with the full right and authority to Grantee, its successors and assigns, and its and their agents and employees, to enter at all times upon said premises for the purpose of constructing, repairing, removing, replacing and maintaining such guy stub anchor pole, guy wires and anchor.

Where applicable, pronouns and relative words used herein shall be read as plural, feminine or neuter.

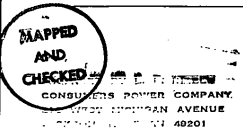
